#### Jon Ridler: Classification Speech

a celebration of the 60year history of the Arlington Heights Chamber of Commerce. He reviewed interesting aspects of the chamber's activities, its heritage . . . and, by popular demand, his own.

He grabbed our attention with photos of Chamber President's—it was great to see how many past and current friends have been

influential in the Chamber. [Bill Kmiecik, you should have a happy fine next week to acknowledge spouse Betsy appearing at the meeting today even though you couldn't!]

Back in 1924, street signs were a major project of the Business Association, a predecessor to the Chamber. Back then folks must have not only known everyone's name, but also where they lived. Jon went on to talk of today's goals and outreach—the Young Professional's committee, Small Proprietor's group serving at-home businesses, and the groups serving Uptown, Downtown and South Town.

A "60-Year Celebration" will be held at the Arlington Park Track on May 5, 2007, with a fun focus on the decades of progress, including music of the times. The Chamber's story is one of success. In 2006 it has 538 members. The 2007 Goal is 600.

An accompanying success story is Jon Ridler's own – married to wife, Sharon, with four great children, Ally, Ben, Carolyn, and Daniel. Jon grew up in Minnesota, so we have to forgive him for rooting for "that" team. He worked in Elgin area youth ministries for ten years, planned regional and national conferences, in the process developed an interest in hospitality and also worked two and a half years with the Elgin Area Convention and Visitors' Bureau.
